Inland Waterways Authority of India (Ministry of Shipping) intends to avail on hire car(s)/Qualis on daily basis and invites sealed bids from interested reputed transport agencies. The bidders may quote the daily hire charges, night stay charge, rate/km and rate/hour for different types of vehicles, as per the enclosed B.O.Q. The rates quotes shall be inclusive of all applicable taxes. The sealed bids may be submitted to Section Officer at the above address, latest by 28/01/2011 (3p.m).

**2. Eligibility criteria:** The transport agency /firm should meet the following pre-qualification criteria for supply of vehicles (of different types) :

- i) The firm should have supplied vehicles to state /central govt deptt/PSU in the last 03 financial years and shall enclose the documentary evidence for the same.
- ii) The firm shall be of good financial background to undertake the work on the subject .
- iii) The firm shall enclose the copy of PAN and copies of I.T return for the last 03 financial
- iv) years.
- v) The firm shall submit the E.M.D of Rs.5,000/ , at the time of the submission of the bids.

**3. Terms & conditions :**

- i) The firm/agencies should be registered one with the appropriate authority.
- ii) The agency shall be income tax assessee and submit the returns for the last 03 years.
- iii) The agency shall submit the attested copies of registration certificate, PAN , proof of E.S.I. and Balance Sheet/Certified Accounts for the last 03 years.
- iv) Quoted rates shall be inclusive of all taxes excluding service tax, which shall be separately separated.
- v) The payments will be made , in accordance with the duty slip attached with the bill, duly certified by the concerned official.
- vi) The firm shall submit a EMD of Rs.5000/- through a DD drawn in favour of "IWAI FUND-KOLKATA" along with the bid.

- vii) The selected bid shall submit a security deposit of Rs.10,000/- in the form of DD drawn in favour of "IWAI FUND-KOLKATA" for amount equal to 10% of contract value after adjusting the EMD.
- viii) The bids received from the bidders shall be opened on 28/01/2011 (at 3.30 p.m) in the presence of the bidders or their authorised representative.
- ix) Payment: payment will be made through E-Payment.
