- 1. Name of Work:** Tender document for Installation and maintenance of lighted FRP/GRP buoys in Alternate Route of Sunderban Waterway
- Inland Waterways Authority of India (IWAI) invites sealed tenders in two cover system (Cover I - Technical bid and Cover II - Financial Bid) from experienced contractors in similar field of work for Installation and maintenance of Lighted FRP/GRP buoys in Alternate Route of Sunderban Waterway

The sealed tenders should super scribe the words “Installation and maintenance of Lighted FRP/GRP Buoys in Alternate Route of Sunderban Waterway”

TERMS & CONDITIONS:-

- Interested bidders may obtain non-transferable bid document by submitting non-refundable demand draft for Rs. 1,000/- (Rupees One Thousand only) drawn in favour of “IWAI FUND” payable at Kolkata. Tender Documents will be available for sale from **29.07.2011 to 04.08.2011 between 1000 hours to 1700 hours (IST)** on any working day from the office of Director, IWAI, P-78, Garden Reach Road, Kolkata - 700 043(WB).

5. The tender document can also be downloaded from the IWAI website “www.iwai.nic.in” Bidders submitting the downloaded version of tender document are required to submit Rs. 1,000/- (Rupees one thousand only) i.e. an amount equal to the cost of tender document along with tender in the form of non refundable demand draft made in favour of “IWAI fund” payable at Kolkata at any nationalized/ schedule bank. A signed declaration stating that no alteration has been made in any form in the downloaded tender document is to be enclosed with the tender by the bidder for downloaded tenders.
6. The tenderer shall meet the following pre-qualification criteria:
- i. The tenderer shall be registered with Central Public Works Department, Railways, MES and State PWD/ Irrigation Department or non-registered contractors having experience of working with IWAI.
 - ii. The tenderer need to be conversant with the functioning of navigational lights and must have prior experience of installing navigational lights/buoys on National Waterways, or on the shipping/barging channel of Major/minor ports if India. **Prior working experience in installation and maintenance of navigation buoy/shore beacon/Tower lights shall be preferred.**
 - iii. Tenderer shall have Permanent Account Number issued by Income Tax Deptt.
 - iv. Average annual financial turnover during last three years ending 31st March of the previous financial year, should be at least 30% of the cost of the present work. Experience of having successfully completed similar works of installation and maintenance of navigational buoys/beacon lights on the National Waterways or on the shipping/barging channel of Major/minor ports if India during the last 7 years ending last day of month previous to the one in which this tender is invited should be either of following:
 - a) Three similar works costing not less than 40% of the estimated cost; **or**
 - b) Two similar works costing not less than 50% of the estimated cost; **or**
 - c) One similar work completed not less than 80% of the estimated cost
 - iv) Latest certificate of solvency from nationalized / scheduled Bank included in the second schedule of the RBI Act for not less than the value indicated below:

- v. Tenderer shall agree to the terms & conditions of the tender and return the tender duly signed in each page for agreeing the same.

- vii. The tenderer shall submit required Earnest Money Deposit in the form of demand draft. Any/all submissions made without the earnest money and/or after the date mentioned hereinafter in clause 6 shall be deemed to be rejected.
- viii. The complete bid as per the tender documents should reach office of Director, Kolkata by 1500 hours on **05.08.2011** and will be opened on same day at 1530 hours.

IWAI reserves the right to accept or reject any or all tenders without assigning any reason and no correspondence shall be entertained in this regard.
