Sealed quotations are invited from the manufacturer/authorized dealer/ stockiest for the supply of POL as per the annexure enclosed herewith on the following terms & conditions.

Terms and conditions: -

- (1) The price rate may be quoted in both words and figures.
- (2) The price may be quoted including all the cost such as labour, materials, taxes, Transportation, etc. No other charges shall be entertained.
- (3) The supply must be completed within 15 days from the date of receipt of supply order at Pandu Port Guwahati in the departmental vessels subject to availability of vessels.
- (4) Xerox copies of Authorization certificate, Valid Sales tax registration certificate, and PAN no. shall be submitted along with quotation.
- (5) The quoted rate shall be declared to be valid till 31.07.2012 or increase/decrease the rate by company from the issue of acceptance order.
- (6) Performance guarantee Rs. 10000/- (Ten Thousand) must accompany quotation. The deposit shall be in favour of "IWAI FUND" in the shape of demand draft on any Nationalised Bank/Schedule Bank of India, payable at Guwahati.
- (6.1) Quotation not accompanied by Performance guarantee amount shall be rejected.
- (6.2) Performance guarantee shall be refunded to the unsuccessful bidder.
- (6.3) Performance guarantee of Successful bidder will be refunded after without any interest after expiry of completion of work & validity period of accepted quotation.
